FINAL AMENDMENT TO TENDER OFFER STATEMENT

This Amendment No. 1 supplements and amends the Tender Offer Statement on Schedule TO filed with the Securities and Exchange Commission on November 19, 2012 by FS Investment Corporation, a Maryland corporation ("FSIC" or the "Company"), in connection with the offer by the Company to purchase up to 2,334,307 shares of its issued and outstanding common stock, par value \$0.001 per share (the "Shares") (which number represents 2.5% of the weighted average number of Shares outstanding for the calendar year ended December 31, 2011). The tender offer was made upon and subject to the terms and conditions set forth in the Offer to Purchase, dated November 19, 2012, and the related Letter of Transmittal (together, the "Offer"). The Offer terminated at 5:00 P.M., Central Time, on December 26, 2012, and a total of 903,718.926 Shares were validly tendered and not withdrawn pursuant to the Offer as of such date. In accordance with the terms of the Offer, the Company purchased all 903,718.926 Shares validly tendered and not withdrawn at a price equal to \$10.00 per Share for an aggregate purchase price of approximately \$9,037,189.26.
