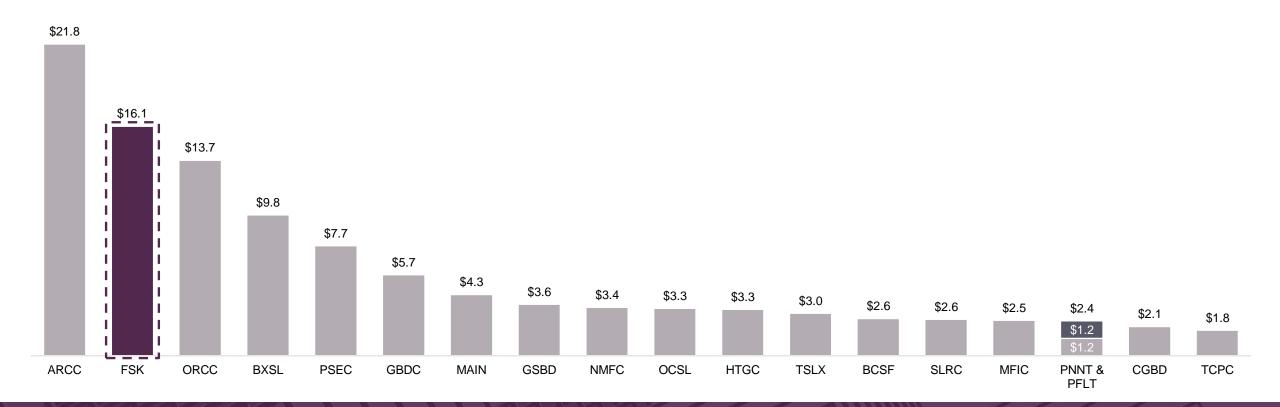

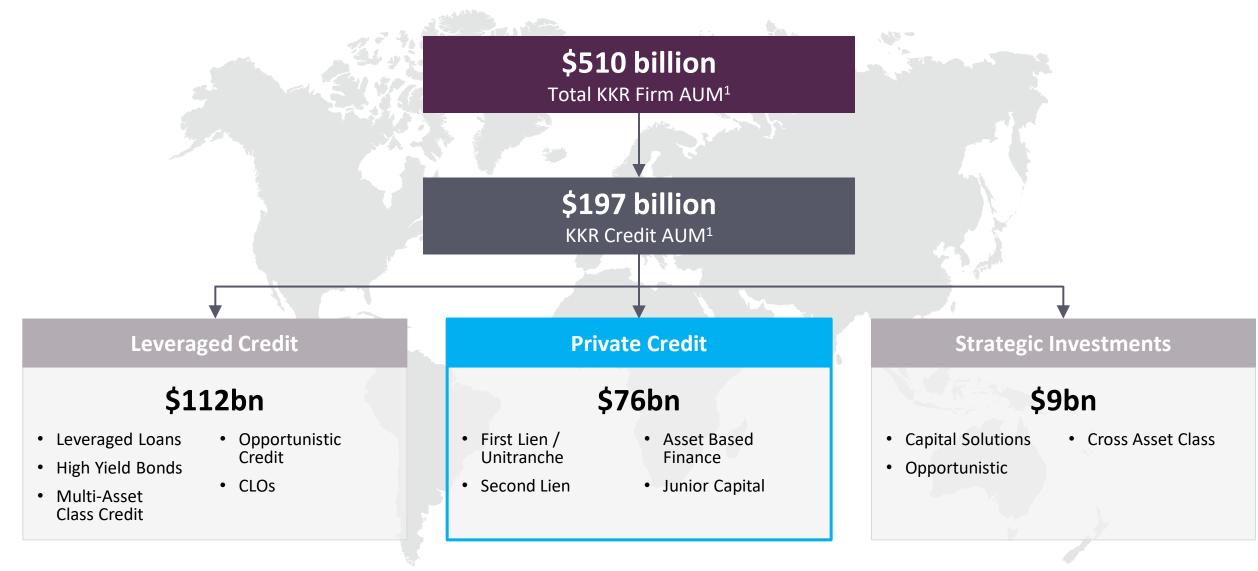
#### **FSK: A Leading BDC**

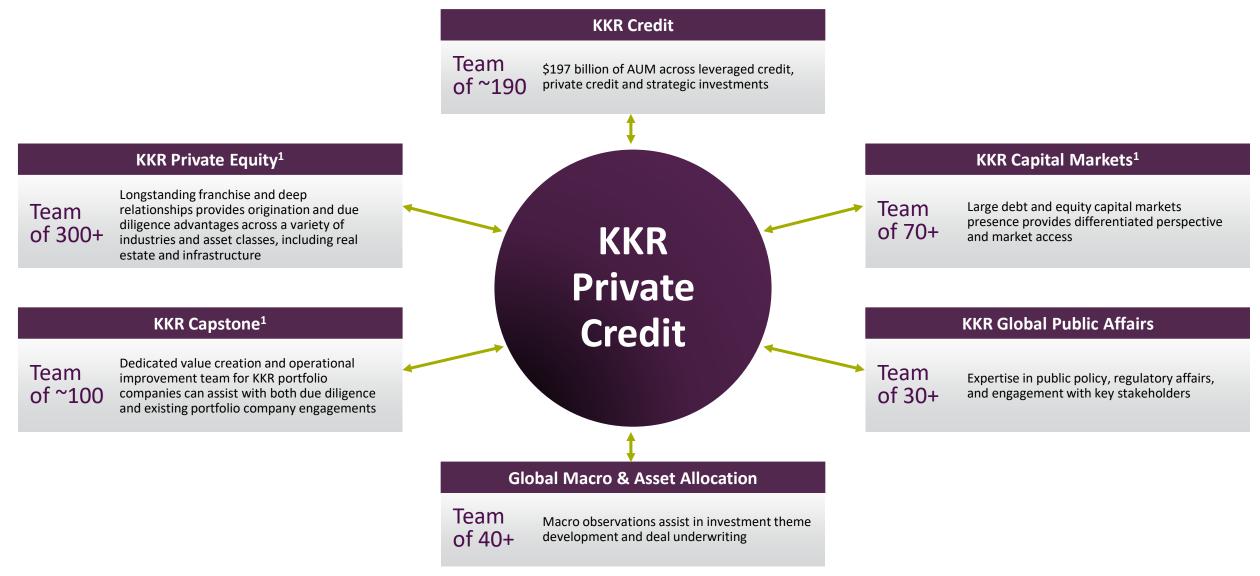

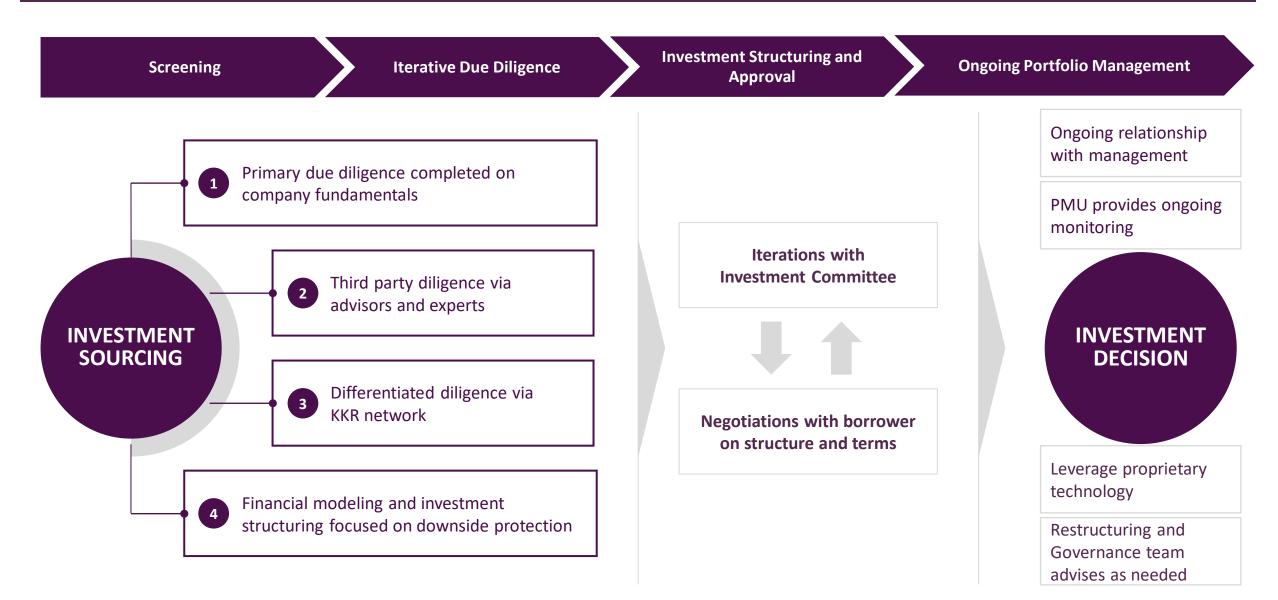

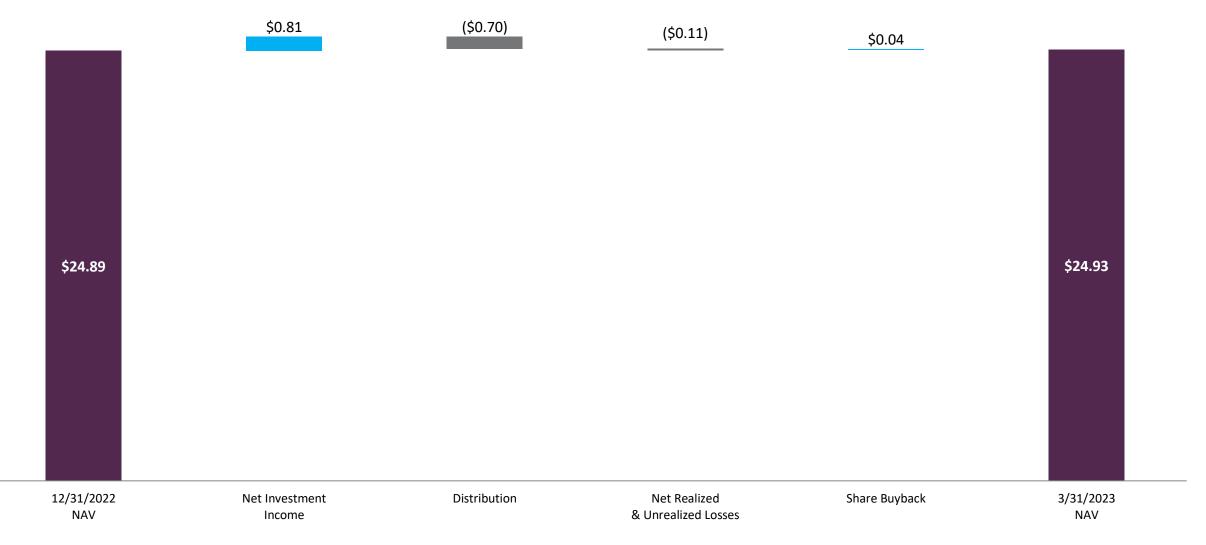

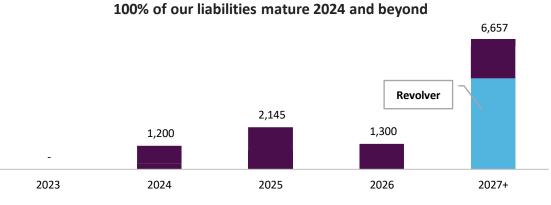

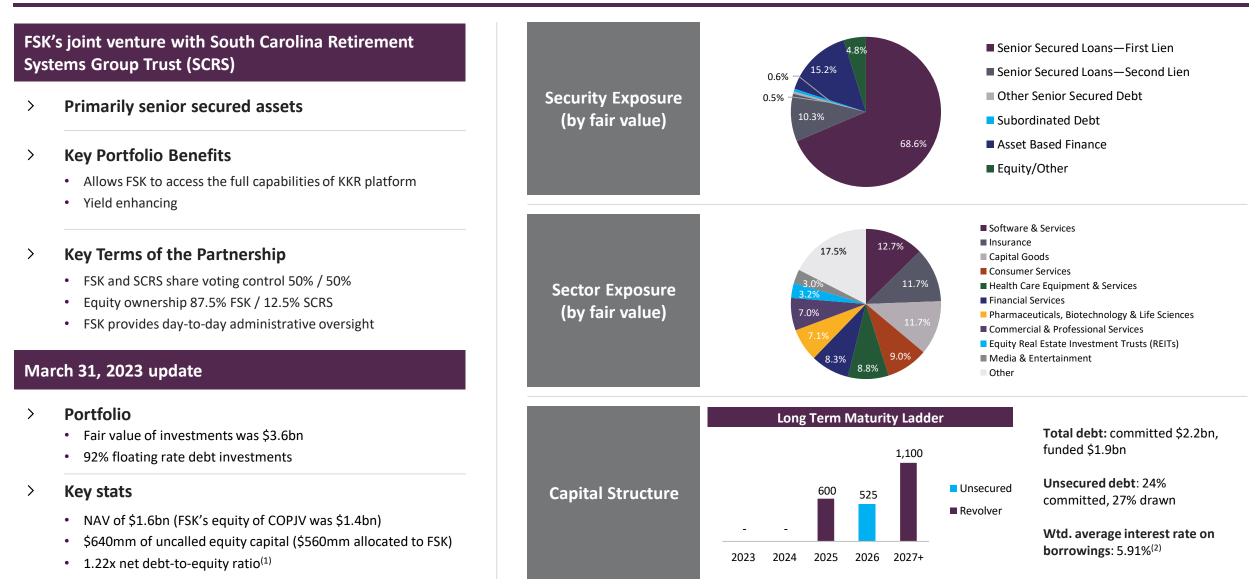

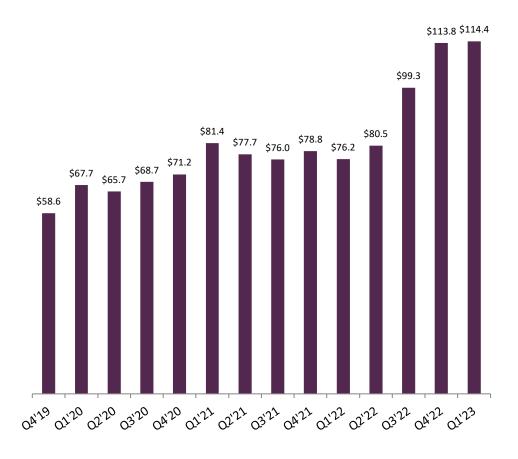

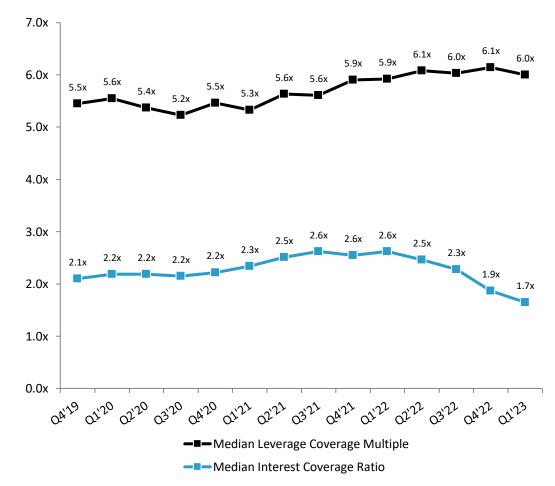

**Direct Origination Portfolio Company Median EBITDA** 



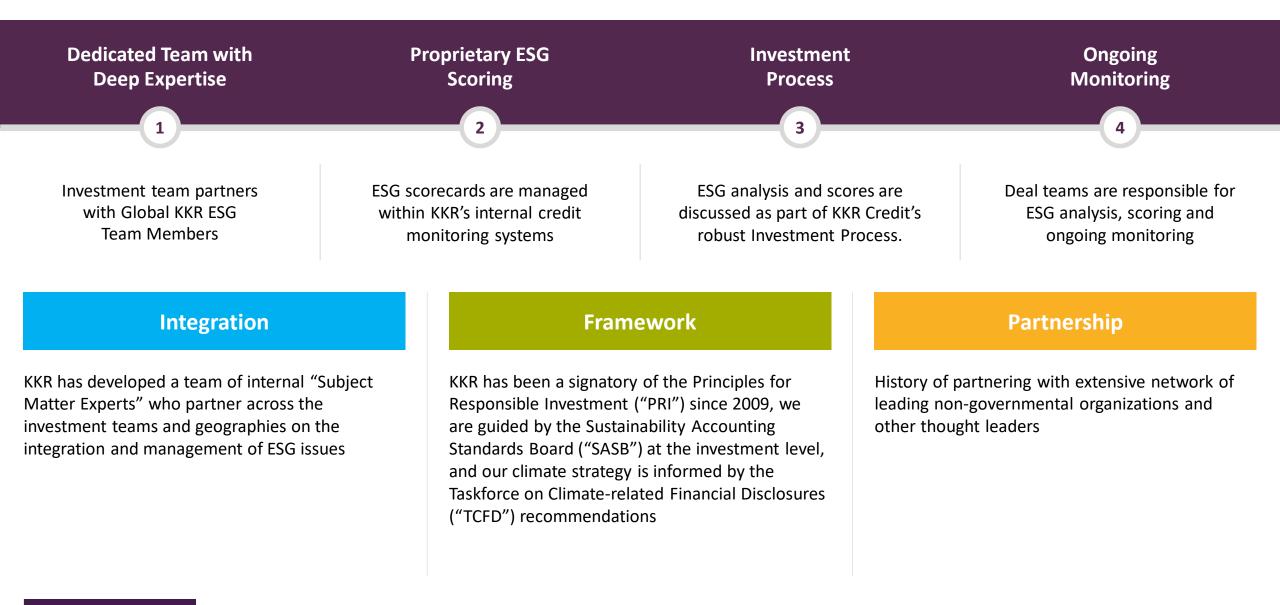
**Direct Origination Portfolio Company Coverage Ratios**
