FINAL AMENDMENT TO TENDER OFFER STATEMENT

This Amendment No. 1 supplements and amends the Tender Offer Statement on Schedule TO filed with the Securities and Exchange Commission on February 15, 2013 by FS Investment Corporation, a Maryland corporation ("FSIC" or the "Company"), in connection with the offer by the Company to purchase up to the lesser of (i) 5,689,475 shares of its issued and outstanding common stock, par value \$0.001 per share (the "Shares") (which number represents 2.5% of the weighted average number of Shares outstanding for the calendar year ended December 31, 2012), and (ii) the number of Shares that the Company can repurchase with the proceeds it receives from the sale of Shares under its distribution reinvestment plan. The tender offer was made upon and subject to the terms and conditions set forth in the Offer to Purchase, dated February 15, 2013, and the related Letter of Transmittal (together, the "Offer"). The Offer terminated at 5:00 P.M., Central Time, on March 25, 2013, and a total of 1,053,119.227 Shares were validly tendered and not withdrawn pursuant to the Offer as of such date. In accordance with the terms of the Offer, the Company purchased all 1,053,119.227 Shares validly tendered and not withdrawn at a price equal to \$10.10 per Share for an aggregate purchase price of approximately \$10,636,504.
