

#### **Conservatively Structured**

- Target leverage set at 1.00-1.25x (1.03x Net Debt-to-Equity as of September 30, 2021<sup>(1)</sup>)
  - Provides cushion to regulatory leverage cap
  - Provides flexibility to be both defensive and aggressive during times of dislocation
- 43% of drawn leverage is unsecured as of September 30, 2021, 52% of proforma drawn leverage is unsecured<sup>(2)</sup>
- 64% of drawn leverage as of September 30, 2021 is not subject to MTM triggers






### **Capital Structure: Rotation Analysis**

#### Wtd. Avg Cost of Debt: 3.1%




#### **Capital Structure Accomplishments**

- Created flexible structure with \$2.5bn of available capital
- Demonstrated access to capital markets
  - Issued one of the largest revolvers in the BDC space
  - Issued \$4.5bn unsecured liabilities across 9 bonds at FSK and another \$525mm at COPJV
  - Issued into the CLO market
- Extending maturities while lowering borrowing costs
  - Weighted average maturity ladder is 4.0 years as of October 31, 2021, compared to 2.2 years prior to FS/KKR Advisor managing FSK
  - Post-merger announcement, FSK issued \$1bn of unsecured notes at 3.40% and \$400mm at 2.625%, compared to a 5.0% weighted average cost of unsecured issuance pre-merger announcement
  - In October 2021, FSK issued \$1.25bn unsecured bonds with a weighted average coupon of 2.54% and a weighted average life of 5.4 years
    - Proceeds were used to fully repay/terminate \$640mm JPM revolver
    - FSK has also issued redemption notice for 5.00% notes due 2022
    - Pro forma weighted average effective rate on borrowings of 3.08%<sup>(1),(3)</sup>






