FINAL AMENDMENT TO TENDER OFFER STATEMENT

This Amendment No. 1 supplements and amends the Tender Offer Statement on Schedule TO filed with the Securities and Exchange Commission on August 22, 2011 by FS Investment Corporation, a Maryland corporation ("FSIC" or the "Company"), in connection with the offer by the Company to purchase up to 582,090 shares of its issued and outstanding common stock, par value \$0.001 per share (the "Shares"), which number represents 2.5% of the weighted average number of Shares outstanding for the calendar year ended December 31, 2010. The tender offer was made upon and subject to the terms and conditions set forth in the Offer to Purchase, dated August 22, 2011, and the related Letter of Transmittal (together, the "Offer"). The Offer terminated at 5:00 P.M., Central Time, on September 27, 2011, and a total of 121,398.599 Shares were validly tendered and not withdrawn pursuant to the Offer as of such date. In accordance with the terms of the Offer, the Company purchased all 121,398.599 Shares validly tendered and not withdrawn at a price equal to \$9.585 per Share (an amount equal to 90% of FSIC's October 3, 2011 public offering price of \$10.65 per Share) for an aggregate purchase price of approximately \$1,163,605.
